This combination, along with the power of the keyboard, enables Ruth to keep her finger on the pulse of critical trends, issues, and opportunities that impact the strength and viability of community nonprofits and the sector as a whole. Ruth will share these trends and much more in her talk that focuses on the very real changes occurring in and around nonprofits since the start of the recession.

Closing Plenary: *The Story of the Indian Law Resource Center*

Tim Coulter, Executive Director, Indian Law Resource Center

Come hear the inspiring story of the Indian Law Resource Center, winner of the 2010 Peter and Patricia Gruber Foundation Justice Prize, which honors organizations and individuals for championing the rights of historically oppressed groups through advocacy, legal reform and the development of international law.

The Indian Law Resource Center, in Helena, MT began with legal work for a single Indian nation—without an office and without any funding. Their work at the United Nations to create a Declaration on the Rights of Indigenous Peoples led to the formal creation of the Center in 1978. The Center refused to accept any government support, and remained very small, supported by small foundations and generous individuals. Their work from the beginning was to challenge United States law and international law, and to work for Indian communities in Mexico, Central and South America as well. In time, the relevance of their work was recognized, and the Center has grown. "We still struggle for our 'daily bread' and take nothing for granted."

PRE-CONFERENCE WORKSHOPS

Developing Leadership in Your Nonprofit

Bao Vang, Leadership Program Coordinator, Minnesosta Council of Nonprofits, St. Paul, MN

This is an exciting and challenging time for nonprofits and leaders within nonprofits. Nonprofits and the people who work in them have an opportunity to rise up and help solve some of the most pressing issues facing our communities today. However, this takes courage and leadership. In this session, you will learn about the challenges facing nonprofits and how nonprofits can develop their capacity to lead in their communities and develop leaders within their organizations. Participants will identify leadership challenges and interactively work with each other to discover new ways and develop new skills to solve these challenges.

Advanced Grantwriting: *From a Funder's View*

Christopher "Kit" Gillem, Program Director, M.J. Murdock Charitable Trust, Vancouver, WA

What makes a strong proposal? What captures the attention of a funder? What are the key elements in a successful proposal? What are the key steps in researching, planning, writing, and submitting a quality proposal? This pre-conference session will be led by a seasoned foundation program officer, Kit Gillem who reads dozens of successful proposals each year and conducts many grantwriting workshops throughout the Northwest. Kit will present his thoughts during this interactive session and will distribute and discuss several proposal documents including goals and objectives, budgets, funding plans and supplemental materials. This workshop is targeted for people with at least five years of experience in grant writing or fund development work. Attendance limited to 35.

Many evaluations focus heavily on methods, data and recommendations, but results are far-to-infrequently used. This session focuses on how evaluation can serve an ongoing strategic learning process that supports and strengthens a true "learning culture" toward increasing impact and taking programs/services to scale. Participants will begin to develop learning plans that can satisfy funder demands, internal decision-making, and stakeholder communication and outreach efforts.

Governance: *Creating Boards That Lead*

This workshop, designed for both management and board members, explores how to form and maintain a governing body that promotes a healthy and successful nonprofit organization. Critical governance, leadership, and management issues will be examined including: strategic to action planning; organizational culture; board roles and legal responsibilities; effective oversight and budgeting strategies; recruiting and maintaining an active board; effective committee structure; and executive director/board relationships. Participants will be revitalized and gain knowledge, understanding, and resources necessary to lead their organization to mission fulfillment. MNA recommends executive staff and board members attend this workshop together.
