PROFESSIONAL AND ORGANIZATIONAL DEVELOPMENT (POD): In 2019, 1,572 people from across Montana participated in one or more of MNA's community workshops or webinars. 449 attended the Annual Conference. MNA hosted workshops on board governance, financial management, next generation leadership, and strategic planning in fourteen communities in Montana. Additional trainings included webinar series on HR and fund development, as well as an author tour featuring Beth Kanter who spoke on workplace wellness and Exponent Philanthropy, who engaged audiences in donor-nonprofit relationship building. Our POD program is supported by a broad array of implementation resources including self-help tools and 1:1 technical assistance.

MEMBERSHIP: In partnership with nearly 700 members, MNA builds visibility, voice and cohesiveness within Montana's nonprofit sector. On behalf of our members, MNA deepens awareness and understanding of nonprofits in Montana through advocacy and information. MNA's e-news is distributed monthly to a listserve of over 4220 subscribers, ensuring timely and useful nonprofit information and resources are disseminated across the MNA network. MNA informs and engages nonprofits in advocacy on broad, sector-wide issues that impact them, including tax exemption and charitable giving issues.
